Community Food Box

When the COVID-19 pandemic began, one of our first concerns was about food supply and access for the community - especially for those who already experience barriers. We know how crises can impact the availability and cost of food, not to mention compounding pre-existing barriers to food access. So, we put our heads together with On The Move Organics and envisioned The Community Food Box Project - a model to deliver boxes of fresh, healthy produce to families who need it.

From March 2020 to March 2021, our partnership delivered a total of 1,345 Community Food Project Boxes to provide enough fresh produce for 21,520 meals for Londoners. While this started out as a temporary program to help combat pandemic-related food insecurity, there are still many families with limited mobility and limited financial means who need this support.

Unfortunately, there is no more funding for the program and it totally relies on donations. Thus, the order form is only open when donations are available. The form will open again on August 25th to match families with donated boxes for September/ October. The order form can be found at <u>https://form.jotform.com/200976185641965</u> on August 25th.

Many benefits are based on you Filing Income Taxes for 2020

July was the month that began to impact all tax credits and pensions that are tax based. London Housing also now requires a copy of your income tax assessment to apply for and maintain your subsidized housing.

Sometimes you just need help to access supports or resources. LIFE*SPIN's Community Advocate, Leia Beland, is there to help. She can assist you to complete applications for:

- disability supports (ODSP, CPP-D, Assistive Devices)
- financial supports (home modification grants, Disability Tax Credits, low-cost internet, pensions, seniors support and benefits)
- subsidized and co-op housing, as well as a request for a property standards inspection
- health benefits (prescriptions, dental, vision, special diet, pregnancy allowance) and Discretionary benefits available through the City.

Housing Issues

Property Standards: If there are issues with your housing, you need to contact your landlord in writing. If you do not hear back from them in two weeks, please send a copy of the letter to property standards enforcement at <u>enforcement@london.ca</u> along with a request for an inspection.

Once the City of London has inspected the property, they may issue an order to the property owner to make repairs. If you would like a copy of the order to file at the Housing Tribunal, you must request a copy of the order from the City.

To get a copy of the Property Standards Order, complete the form at <u>https://london.ca/</u> <u>sites/default/files/2020-08/MFIPPA%20access%20or%20correction%20request.pdf</u> Send the completed request form to the "Manager, Records and Information Services", City Clerk's Office, City Hall, 300 Dufferin Ave, London, ON, N6A 4L9. You must enclose \$5.00 with your request.

To file your request to the Housing Tribunal https://tribunalsontario.ca/documents/ltb/ Brochures/Maintenance%20and%20Repairs%20(EN).html One of the remedies that you can request from the Housing Tribunal is rent abatement (less rent) until the repairs are made. The Property Standards Order should be attached to your application, as evidence.
