Many of London's working poor, those new to unemployment and families surviving on social assistance are struggling to house, feed, and clothe themselves, and their families, as well as meet the special challenges created by the Covid-19 pandemic.

We refer you to our website: **lifespin.org** to provide information on income supports and resources that are available to help you through the difficult challenges you are struggling with. There is information on access to food, income supports, community resources, mental health supports, and children's activities and programs. We hope this information will help you find the supports you need.

LIFE*SPIN Community Advocate

Depending on the situation, LIFE*SPIN is still providing information, support and community-based programs to low-income Londoners through remote services.

Sometimes you just need help to access supports or resources. LIFE*SPIN's Community Advocate, Leia Beland, is there to help. She can assist you to complete applications for:

• disability supports (ODSP, CPP-D, Assistive Devices)

• financial supports (home modification grants, Disability Tax Credits, low-cost internet, pensions, seniors support and benefits)

• subsidized and co-op housing, and a request for a property standards inspection

• health benefits (prescriptions, dental, vision, special diet, pregnancy allowance) and Discretionary benefits available through the City.
